**PLEASE NOTE:**

If Annual Subscription fees are not paid by the due date,

- (a) membership ceases and voting rights are suspended, but
- (b) membership can be re-instated up to 30 days after the due date upon receipt of the Annual Subscription fee plus the applicable Joining fee,
- (c) beyond 30 days after the due date, membership must be reapplied for.
