SUBSCRIPTION FEE

If annual subscription fees are not paid by the due date,

- a) Membership ceases and voting rights are suspended, but
- b) Membership can be re-instated up to 30 days after the due date upon receipt of the Annual Subscription fee, **plus the applicable joining fee.**
- c) Beyond 30 days after the due date, membership must be reapplied for.
